

Baby's First Milestones Giveaway by Similac® StrongMoms®

Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: Baby's First Milestones Giveaway by Similac® StrongMoms® (the "Promotion") is open only to legal residents of the fifty (50) United States (including District of Columbia) who are at least eighteen (18) years old at the time of entry and who are StrongMoms® members (membership is free). Employees of Abbott Laboratories, HelloWorld, Inc., and their parent and affiliate companies, suppliers as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. The Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited. Administrator's computer is the official time-keeping device for this Promotion. For purposes of this Promotion, a "day" begins at 12:00 a.m. ET and ends at 11:59 p.m. ET, except for the first day which begins at 12:00 p.m. ET and ends at 11:59 p.m. ET and the last day which begins at 12:00 a.m. ET and ends at 11:59 a.m. ET.

4. How to Enter: During the Promotion Period, visit www.similac.com/registration to become a StrongMoms member. Fill out the registration form completely and check the box indicating you would like to participate in the Promotion and you will automatically receive one (1) entry into the Sweepstakes and one (1) Instant Win Game play for that day. If you are already a StrongMoms member, visit <https://similac.com/sweepstakes> (the "Website") to login to the Promotion and you will automatically receive one (1) Sweepstakes entry and one (1) Instant Win Game play for that day. Once on the Instant Win Game page, follow the links and instructions to play the Instant Win Game. The Instant Win Game results will be instantly displayed. Potential winners of the Instant Win Game will be provided directions for validation. All potential winners are subject to verification before any prize will be awarded. Administrator is responsible for the functionality of the Instant Win Game.

Limit: Each entrant may enter the Sweepstakes and play the Instant Win Game one (1) time per day during the Promotion Period. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of plays/entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's plays/entries and that entrant will be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible or misdirected registrations, which will be disqualified. In the event of a dispute as to any registration or play, the authorized account holder of the email address used to register will be deemed to be the entrant or player. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. You may earn one (1) additional Sweepstakes entry per day during the Promotion Period via this method.

c. Watch a Video: After you register for the Promotion or login, follow the links and instructions to click on the "Watch Video" button and watch a video and you will automatically receive one (1) additional Sweepstakes entry. You may earn one (1) additional Sweepstakes entry per day each time you watch the entire posted video during the Promotion Period.

5. Sweepstakes/Instant Win Game: Administrator is an independent judging organization whose decisions as to the administration and operation of the Promotion and the selection of potential winners are final and binding in all matters related to the Promotion. Sweepstakes: Administrator will randomly select the potential Sweepstakes winner, from all eligible entries on or around April 19, 2018. Instant Win Game: Three hundred (300) random, computer-generated winning times, one (1) for each Instant Win Game prize listed below, will be generated during the Promotion Period. If you are the first player to play the Instant Win Game at or after one of the randomly-generated times, you will be a potential instant winner of the prize indicated.
